I hereby warrant and represent that I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in the **ACTIVITIES** and I expressly agree to assume the entire risk of any accident personal injury, including death, damage to property or any other harm which I may suffer as a result of my participation in the **ACTIVITIES**, notwithstanding any

prevailing weather, road or other conditions and any other factors which may impact or affect in any way the conduct of the **ACTIVITIES** or my participation therein.
